

CODICIL FOR POUR OVER WILL

THERE ARE NO REPLACEMENT PAGES FOR THE POUR OVER WILL. A WILL CANNOT BE ALTERED BY SUBSTITUTING PAGES DIRECTLY ONCE IT IS WITNESSED. TO HAVE A VALID AMENDMENT TO THE WILL YOU SHOULD COMPLETE THE CODICIL FORM AND ATTACH A REPLACEMENT PAGE TO IT. COMPLETE THE CODICIL AND NEW FORMS, THEN HAVE THEM SIGNED AND WITNESSED (you will need to sign in the presence of 2 witnesses. Remember that you cannot witness your own will or that of a your spouse if married). CARE SHOULD BE TAKEN TO PLACE THE DATE OF THE ORIGINAL WILL ON THE APPROPRIATE LINE IN THE CODICIL. THE NEW CODICIL WILL HAVE A MORE RECENT DATE OF SIGNING THAN THE OLD WILL. CALL IF QUESTIONS.
